

**OFF-LICENCE**

Sections 17 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **INDEPENDENT BRANDS LIMITED** (the licensee) is authorised to sell alcohol from the premises situated at 1A Parore Street Dargaville, Kaipara District and known as "Independent Brands" to any person for consumption off the premises.

**ENDORSEMENT**

Section 40 of the Act applies to this licence; and the licensee is authorised to sell alcohol from (but not on) the premises and deliver it somewhere else.

**CONDITIONS**

This licence is subject to the following conditions:



- (a) No alcohol is to be delivered on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day.
- (b) Alcohol may be sold on the following days and during the following hours:  
Monday to Sunday (7 days) 24 hours
- (c) The fees payable for the licensing of the premises concerned are the following risk rating: Medium.

**DURATION**

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) Until the close of the period of 1 year commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period for which it is renewed.

## NOTICE OF RENEWAL OF OFF LICENCE

Section 135, Sale and Supply of Alcohol Act 2012

The off licence in respect of the premises situated at 1A Parore Street Dargaville, Kaipara District and known as "Independent Brands" is renewed on the terms and conditions set out in replacement licence number 03/OFF/008/2018.

Subject to the requirements of the Act relating to the payment of fees, and the provisions of the Act relating to the suspension and cancellation of licences, the replacement licence shall expire on 4th day of April 2021, unless an application for renewal is duly made.

The licensee's attention is also drawn to sections 56 and 57 of the Act obliging the holder of an off-licence to display:

- (i) A sign to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of alcohol; and
- (ii) A copy of the licence, and of the conditions of the licence, attached to the interior of the premises so as to be easily read by persons entering through each principal entrance; and
- (iii) A sign prominently displayed inside the premises, which identifies by name the manager for the time being on duty.

The licensee is reminded of their responsibilities with regard to the object of the Sale and Supply of Alcohol Act 2012.
